## STATED CLERK COMPENSATION PACKAGE 2022-2023

- 1. Full-time 40 hours per week
- 2. 3% COLA increase (previously approved by Presbytery) and a 2% merit increase. Total base salary \$92,790.00
- 3. Provide \$400 per month/\$4800.00 per year contribution to the Presbytery 403b plan.
- 4. \$10 per month term life insurance premium payment Presbytery now provides.
- 5. Reimbursement for professional expenses incurred in the performance of job responsibilities up to the amount budgeted for the calendar year.
- 6. Two weeks study leave; \$2000.00 professional development stipend.
- 7. Vacation time accrual in accordance with the terms of the Presbytery Employee Handbook.
- 8. Paid sick leave according to the City of San Diego Sick Leave Ordinance and the Presbytery Employee Handbook.
- 9. Effective Jan 1, 2022 for a one year term.
