Statement of Faith

Cassie Carroll April 18, 2022

God is the Creator of all things and created humanity in God's image. God is complete, holy, and present. God desires an intimate relationship with God's creation, not out of necessity but out of sacrificial love. The love that God has for creation is unconditional, consistent, and unending. God is fully experienced through the three persons of the Trinity: Creator, Savior, and Intercessor. Each of the Trinity is fully God, neither being lesser than the other persons.

Report of Linda Vista Administrative Commission May 17, 2022

Members of the Presbytery are invited to attend a celebration of the eighty-plus-year ministry of the Linda Vista Presbyterian Church on Saturday, June 11, 2:00 p.m., 2130 Ulric Street, San Diego. A brief worship service will include favorite hymns, photographs, and memories of the congregation, followed by a reception in the fellowship hall. The Administrative Commission encourages our fellow presbyters to be part of this service of thanksgiving. The final worship service will be held the next day, Sunday, June 12, 10:00 a.m. with the Reverend Bryan Kile preaching. The Rev. Kile, a retired Presbyterian pastor from Texas, has been graciously and effectively serving LVPC since December.

The Linda Vista Administrative Commission has met three times as the commission and has attended and/or moderated two meetings of the Session. The team is working hard to prepare for issues surrounding the formal and legal closing of the congregation on June 30, 2022, and for interim arrangements that will enable the Vine Learning Center and three worshiping congregations to continue on site in July and beyond until the Commission makes its final report and recommendations to the Presbytery.

The Commission has written a letter to the congregation, expressing our appreciation for the four-decade ministry of Linda Vista Presbyterian Church and our pastoral concerns for current members of the church. An invitation to consider joining any of the churches of the presbytery was offered, as well as a link to the presbytery's list of churches. Laura Metzger of our team attended worship on May 15, expressing our care for the congregation and willingness to help those seeking another congregation. She developed a list of nearby congregations and their worship times for distribution to the people of Linda Vista.

The Commission has scheduled meetings with the Vine Preschool and the three continuing congregations (Ebenezer Church, Young Nak Presbyterian Church, and Palabra De Vida) to assess current and future use of the building for worship and ministry. It has been communicated to all parties that current schedules and room use are to continue without adjustment, and that changes can only be made by the Administrative Commission, with such changes communicated to all concerned in writing.

Among the options under consideration for ultimate disposition of the property are:

- 1) sale of the property (the Vine Preschool has right of first refusal)
- 2) ongoing management of the property by a third-party while maintaining presbytery ownership
- 3) oversight of the property by a Presbytery congregation with the intent of continuing and expanding congregational ministry on site. The Commission sought a meeting with elders of La Jolla Presbyterian Church after learning there had been some discussion of this third possibility

at La Jolla. Early indications are that such an arrangement is possible with the presbytery retaining ownership, and income generated by the property to be reinvested in ministry there in Linda Vista.

All these options are in the early stages of discussion and would require the approval of the Presbytery.
